All reservations are subject to a \$50.00 non refundable reservation fee (included in the rental price). Reservations canceled within 14 days of the scheduled pick up date are subject to a \$150.00 cancellation fee. No shows are charged the full amount of the rental.

5. ACKNOWLEDGEMENT BY RENTER:

Renter acknowledges receipt of the property in good operating condition. All equipment is functional and all parts of the property and assemblies are in place.

6. OWNERSHIP AND LIABILITY FOR DAMAGE OR LOSS;

We own and retain title to the property. In the event that the property is stolen, lost, damaged, or destroyed during the term of this agreement, including renewals and extensions, the renter is fully responsible to the owner for the replacement value of the property at the time of any such loss or damage. Renter is responsible to the owner for any loss or damage to the property regardless of whether the property is operated by someone other than the renter without the renter's knowledge or permission.

7. IN THE EVENT OF DAMAGE OR LOSS;

In the event of damage or loss, notify Little Guy Trailers, toll free at (866) 977-7607. You are ultimately responsible for any loss, damage, or tow fees required to return the trailer to Little Guy in San Diego.

TRAILER USE INSTRUCTIONS AND RECOMMENDATIONS

GENERAL SAFETY RECOMMENDATIONS

1. Always secure trailer hitch and safety chains prior to towing.
2. Check all lights; brakes, tail, turn signals and markers.
3. Lock both side doors and hatch knobs during transit.
4. Secure all cargo to prevent shifting and damage
5. Do not tie anything to the top of the trailer.
6. Obey all speed limit and trailer towing regulations.
7. Always be aware of the trailer behind you. Avoid making sharp turns.
8. Instead of backing...trailer can be unhitched and rolled into camp site.
9. Double check chains and ball lock before towing.
10. Do not allow anybody to ride in the trailer while moving.

USE OF TRAILER

1. Trailer is for camping only.
2. Do not put excessive weight on the galley shelf.
3. Remove camp stove before use. **DO NOT USE STOVE IN CARGO AREA.** This could result in damage or fire.
4. Properly clean stove and trailer prior to rental return.
5. Leave trailer attached to tow vehicle at night for added security and stability.
6. Lock doors, hatch, and tow ball when leaving the trailer unattended. Ultimately you are responsible for any damage or loss.
